**DESIST AND REFRAIN ORDER**  
**(For Violations of Corporations Code section 25110 and 25210)**

The California Corporations Commissioner finds that:

1. David McEuen (hereinafter, "McEuen") is a natural person and a resident of California. His last known address is 1612 Liberty Drive, S. Corona, CA 92881. His last known business address is 2428 Newport Blvd., #5, Costa Mesa, CA 92627.
2. At all relevant times, MQN Investments (hereinafter MQN) is or was a business entity operating from and within California. MQN is not incorporated in California and has not made a fictitious business name filing in any California county. MQN appears to be a dba of McEuen. MQN's addresses and phone numbers are the same as McEuen's addresses and phone numbers.
3. MQN's website (www.MQNInvestments.com) states that MQN "invests and/or markets and raises capital for all types of real estate and business ventures whether they are our own or others and whether they are an existing business or a start up business." Neither McEuen nor MQN has applied

1 for or secured a certificate from the California Corporations Commissioner authorizing it to act as a  
2 broker and/or dealer of securities in the State of California.

3 4. In addition to MQN, it appears that McEuen operates other ventures under several other dbas.  
4 McEuen's other dbas, include, but may not be limited to, (1) MQN Media, (2) The Brewery  
5 Restaurants, Inc., (3) Killer Industries, Inc. (a suspended California corporation) (4) Roof Repair  
6 Made Easy, (5) Island Tan, and (6) The Rock and Roll Travel Show.

7 5. On MQN's website, each of these dbas appear to be separate companies or businesses,  
8 however, each is owned or controlled by McEuen and/or a member of his family. McEuen and  
9 MQN, through the internet and on his/its website, www.MQNInvestments.com, has and is currently  
10 offering and/or selling securities in some or all of these companies.

11 6. Beginning in or before October 2006, McEuen and MQN offered and/or sold shares in Roof  
12 Repair Made Easy. Roof Repair Made Easy is/was a company that intended to produce DVDs for  
13 do-it-yourselfers about roof repair. The DVDs were intended for sale in Home Depot, Lowe's, OSH,  
14 and other similar stores. The offering was designed to raise \$900,000, initially, and then another  
15 \$1,800,000+ to cover production costs in phase two.

16 7. The securities offered and/or sold in Roof Repair Made Easy were not qualified for sale in  
17 California.

18 8. At some point prior to July 21, 2007, McEuen and MQN offered and/or sold securities in  
19 "The Brewery at Corona Point," a brew pub and restaurant in Corona, California. The above-  
20 described website, www.MQNInvestments.com, claims that the investment was closed on July 21,  
21 2007, because it has been fully funded at this point in time.

22 9. The securities offered and/or sold in The Brewery at Corona Point were not qualified for sale  
23 in California.

24 10. On and after November 7, 2006, the website's page devoted to Killer Industries stated:  
25 "INVESTORS WANTED." It also stated "we are looking for investors to put us into orbit."  
26 McEuen is the listed as the agent for service of process for this suspended corporation on the  
27 California Secretary of State website.

28 11. The securities offered and/or sold in Killer Industries were not qualified for sale in California.

1 12. In fact, none of the securities offered and sold by David McEuen and/or MQN Investments  
2 were ever qualified with the Commissioner of the Department of Corporations, nor were they  
3 exempt. These offerings include the aforementioned dba Island Tan and an offering selling interests  
4 in a television program named “The Rock and Roll Travel Show,” although fewer details of these  
5 offerings were made available on McEuen’s/MQN’s website.

6 13. These securities were offered and sold by David McEuen in this state in issuer transactions.  
7 The Department of Corporations has not issued a permit or other form of qualification authorizing  
8 any person to offer and sell these securities in this state.

9 14. In addition, these securities were purportedly offered and/or sold through MQN Investments,  
10 which was ostensibly acting as the broker dealer of the securities, although no broker dealer  
11 certificate was ever issued by the Corporations Commissioner to either McEuen or MQN  
12 Investments.

13  
14 Based on the foregoing findings, the California Corporations Commissioner is of the opinion  
15 that the investments (whether investment contracts, stock, shares, or other types of securities) in each  
16 of the above-mentioned companies that were offered and/or sold by David McEuen and MQN  
17 Investments are securities subject to qualification under the California Securities Law of 1968 and are  
18 being or have been offered or sold in violation of California Corporations Code section 25110.

19 Pursuant to section 25532 of the Corporate Securities Law of 1968, David McEuen, MQN  
20 Investments, MQN Media, The Brewery Restaurants, Inc., Killer Industries, Inc., Roof Repair Made  
21 Easy, Island Tan, and The Rock and Roll Travel Show are hereby ordered to desist and refrain from  
22 the further offer and sale of securities in the State of California, including but not limited to  
23 investment contracts, stock, shares, or other types of securities, unless qualified or exempt.

24  
25 Based on the foregoing findings, the California Corporations Commissioner is of the opinion  
26 that David McEuen and MQN Investments was and is holding himself/itself out as a broker dealer  
27 without first acquiring a certificate from the Commissioner of Corporations in violation of section  
28 25210 of the California Corporations Code.

Pursuant to section 25532 of the Corporate Securities Law of 1968, David McEuen and MQN Investments are hereby ordered to desist and refrain from further violations of section 25210 of the California Corporations Code unless they have applied for and secured from the Commissioner a certificate, then in effect, authorizing them to act in that capacity, or unless exempt.
