14 **DESIST AND REFRAIN ORDER**
15 **(For violations of section 25110 of the Corporations Code)**

16 The Commissioner of Corporations finds that:

17 1. Scarsdale Energy Partners, LLC (“Scarsdale Energy Partners”) is a limited liability
18 company organized under the laws of Delaware on April 18, 2008. At all relevant times, its principal
19 place of business was 58 Webster Road, Scarsdale, NY 10583.

20 2. Scarsdale Drilling Partners II LP (“Scarsdale II”) is a limited partnership organized
21 under the laws of Delaware on April 24, 2008. At all relevant times, its principal place of business
22 was also 58 Webster Road, Scarsdale, NY 10583. Scarsdale II also has a place of business at 10
23 Bank Street, Suite 560, White Plains, NY 10606.

24 3. Scarsdale Drilling Partners III LP (“Scarsdale III”) is a limited partnership organized
25 under the laws of Delaware on May 6, 2008. At all relevant times, its principal place of business was
26 58 Webster Road, Scarsdale, NY 10583.

27 4. Scarsdale Energy Partners, Scarsdale II, and Scarsdale III are in the oil business.
28 Scarsdale Energy Partners is the general partner in both Scarsdale II and Scarsdale III.

1 5. At all relevant times, Lawrence Doherty, also known as Larry Doherty (“Doherty”),
2 was a managing partner of Scarsdale Energy Partners. Doherty’s business address is 58 Webster
3 Road, Scarsdale, NY 10583.

4 6. At all relevant times, YuWen Creech (“Creech”) was a managing partner of Scarsdale
5 Energy Partners. Creech’s business address is 522 Hunt Club Blvd. #149, Apopka, FL 32703.

6 7. Beginning in 2008 or earlier, Doherty, Creech, Scarsdale Energy Partners, Scarsdale
7 II, and Scarsdale III offered and sold investment contracts in the form of limited partnership interests
8 in Scarsdale II and Scarsdale III.

9 8. These investment contracts are securities. These securities were offered or sold in this
10 state in issuer transactions. The Department of Corporations has not issued a permit or other form of
11 qualification authorizing any person to offer or sell these securities in this state.

12 9. Doherty, Creech, Scarsdale Energy Partners, Scarsdale II, and Scarsdale III, directly
13 and through their agents, offered and sold these securities to people, including one or more residents
14 of California, with whom they had no preexisting relationship.

15 Based upon the foregoing findings, the Commissioner of Corporations is of the opinion that
16 the investment contracts that are being or have been offered or sold by Lawrence Doherty, also
17 known as Larry Doherty; YuWen Creech; Scarsdale Energy Partners, LLC; Scarsdale Drilling
18 Partners II LP; and Scarsdale Drilling Partners III LP are securities subject to qualification under the
19 California Corporate Securities Law of 1968 and are being or have been offered or sold without being
20 qualified in violation of Corporations Code section 25110. Pursuant to Corporations Code section
21 25532, Lawrence Doherty, also known as Larry Doherty; YuWen Creech; Scarsdale Energy Partners,
22 LLC; Scarsdale Drilling Partners II LP; and Scarsdale Drilling Partners III LP are hereby ordered to
23 desist and refrain from the further offer or sale in the State of California of securities, including but
24 not limited to investment contracts, unless and until qualification has been made under the law or
25 unless exempt.
