Commercial Banks

On January 1, 2005, there were 174 state-chartered commercial banks. During the year, 22 commercial banks opened for business. Two national banks and one federal savings bank converted to state-chartered commercial banks and one state-chartered commercial bank converted to national charter. Eleven commercial banks became extinct through merger, bringing the total number of state-chartered commercial banks to 187 at yearend.
