21 IT IS HEREBY STIPULATED by and between Plaintiff, Preston DuFauchard  
22 California Corporations Commissioner (“Plaintiff”) and Defendants Ronald M. Wilson, Rome  
23 Finance Company (GA), LLC and William Collins (“Defendants”) that upon the filing of a  
24 declaration of default in the form provided for in the Settlement Agreement, the Judgment previously  
25 entered in this matter be amended to include civil penalties as follows:  
26 Judgment in favor of Preston DuFauchard California Corporations Commissioner and against  
27 Ronald M. Wilson, Rome Finance Company (GA), LLC, and William Collins, in the sum of  
28 \$4,500,000.00, less credit for any payments received by Plaintiff from Defendants pursuant to the

1 settlement of this action upon the following terms:

2 1. Upon the filing of a declaration of default in the form as required by the Settlement  
3 Agreement, Ronald M. Wilson, Rome Finance Company (GA), LLC and William Collins hereby  
4 waive any and all rights to notice, presentment, or hearing with respect to any proceedings relating to  
5 this Stipulation or entry of any Judgment, and hereby waive any and all rights to trial, to move for a  
6 new trial, or for reconsideration, to a statement of decision, to notice of entry of judgment, or to  
7 appeal, with respect to the entry of judgment. Any hearing needed in relation to this Stipulation, or  
8 obtaining any judgment thereon, may be heard on an ex parte basis (without any notice to Defendants  
9 or their counsel), by submission by Plaintiff of declarations without oral argument.

10 2. This Stipulation may be executed in multiple counterparts, each of which shall be  
11 deemed an original Stipulation, and all of which shall constitute one Stipulation.
