(For violations of sections 25110 of the Corporations Code)

The California Corporations Commissioner finds that:

- At all relevant times, RTO Investors, LLC ("RTO") was a California limited liability company founded on July 13, 2011, specializing in structuring tenant-in-common investments for passive investors.
- 2. Sam Hales ("Hales") is a natural person and believed to be a resident of California. According to RTO's website, www.RTOInvestors.com, Hales is the Chief Executive Officer ("CEO") of RTO and personally oversees each transaction.
- 3. As of December 29, 2010, Hales has used the dba Silverback Realty ("Silverback").
- Scott Keate ("Mr. Keate") is a natural person and believed to be a resident of California. 4.
- According to RTO's website, Mr. Keate is the Vice President of business development, including managing the company's website and web content.
- 23 5. Melanie Keate ("Mrs. Keate") is a natural person and believed to be a resident of California.
- 24 According to RTO's website, Mrs. Keate is the Vice President of Investor Relations. She is 25 responsible for guiding investors through the purchase process.
- 26 Both of the business entities as well as the three individual persons identified above have a business address of 1577 Eden Forest Dr., Colfax, CA 95713.
 - 7. Beginning in or about July 2011, and continuing to the present, RTO, Silverback, Hales, and

	Mr. and Mrs. Keate offered and sold securities in the form of tenant-in-common investment contracts
	by advertising on the internet, offering these securities on the company website, touting and puffing in
	YouTube videos, and marketing through social networking sites like Facebook, through internet
	chatting, word of mouth and other forms of general solicitation.
	8. The securities were offered and sold in this state in issuer transactions. The Department of
	Corporations has not issued a permit or other form of qualification authorizing any person to offer and
	sell these securities in this state.
	Based upon the foregoing findings, the California Corporations Commissioner is of the opinion
	that the tenant-in-common investment contracts that are being and have been offered and sold by RTO
	Investors, LLC, Silverback Realty, Sam Hales, Scott Keate and Melanie Keate are securities subject to
	qualification under the California Corporate Securities Law of 1968 and are being or have been
	offered and sold without being qualified in violation of Corporations Code section 25110. Pursuant to
	section 25532 of the Corporate Securities Law of 1968, RTO Investors, LLC, Silverback Realty, Sam
	Hales, Scott Keate and Melanie Keate, are hereby ordered to desist and refrain from the further offer
	or sale in the State of California of securities, including but not limited to tenant-in-common
	investment contracts, unless and until qualification has been made under the law or unless exempt.
	This Order is necessary, in the public interest, for the protection of investors and consistent

with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
