STIPULATION TO DESIST AND REFRAIN ORDER

18 IT IS HEREBY STIPULATED AND AGREED between Desert Wind Entertainment, LLC;
19 Joshua Mills; Steven Camp; and T.J. Amato (hereinafter "Respondents") and the California
20 Corporations Commissioner ("Commissioner"), as follows:

21 WHEREAS, Respondents admit the jurisdiction of the California Department of
22 Corporations over their persons and over the subject matter of this Stipulation;

23 WHEREAS, Respondents waive the right to any hearing, including that provided by
24 California Corporations Code sections 25532, subdivision (d), and 25609. Further, Respondents
25 waive any and all review by a court of law, including that provided by California Government Code
26 section 11523;

27 WHEREAS, all terms used, but not defined herein, shall have the meaning assigned to them
28 by the California Corporations Code;

1 WHEREAS, Respondents represent that no promises of any kind or nature whatsoever were
2 made to induce Respondents to enter into this Stipulation, and that this Stipulation is a voluntary act
3 on the part of Respondents;

4 WHEREAS, Respondents, without admitting or denying any of the findings contained within
5 the Desist and Refrain Order (“Order”), in the form attached hereto as Exhibit A, hereby agree and
6 stipulate to the Order;

7 WHEREAS, Respondents agree and acknowledge that nothing in this Stipulation shall
8 preclude the Commissioner or his agents, officers, or employees, to the extent authorized by law,
9 from sharing any evidence or information regarding this matter with any other state or federal law
10 enforcement official, or from assisting or cooperating with regards to any investigation and/or
11 action;

12 WHEREFORE, Respondents Desert Wind Entertainment, LLC; Joshua Mills; Steven Camp;
13 and T.J. Amato stipulate and agree to the finality of the Order. Respondents further understand and
14 agree that the Order remains in effect, is public and that Respondents cannot deny the violations
15 cited in the Order or make any statement or representation that is inconsistent with this Stipulation or
16 the Order. Respondents further understand and agree that this Stipulation does not prevent the
17 Commissioner from taking future action in regard to this matter.
18

19 This Stipulation may be executed in one or more counterparts, each of which shall be an
20 original but all of which, together, shall be deemed to constitute a single document. A fax signature
21 shall be deemed the same as an original signature.

DESIST AND REFRAIN ORDER
(For violations of section 25110 of the Corporations Code)

The California Corporations Commissioner finds that:

1. Desert Wind Entertainment, LLC (“Desert Wind Entertainment”) is a limited liability company formed under the laws of California on December 9, 2008. Its principal place of business is 6355 Topanga Canyon Boulevard, Suite 411, Woodland Hills, CA 91367.
2. At all relevant times, Joshua Mills (“Mills”) was the president, chief executive officer, and a control person of Desert Wind Entertainment.
3. At all relevant times, Steven Camp (“Camp”) was the vice president of finance, chief financial officer, and a control person of Desert Wind Entertainment.
4. At all relevant times, T.J. Amato (“Amato”) was a control person of Desert Wind Entertainment.

5. At all relevant times, Patricia Gillum (“Gillum”) was a co-production partner of Desert Wind Entertainment.

6. Beginning in 2009 or earlier, Desert Wind Entertainment, Mills, Camp, Amato, and Gillum offered and sold securities in the form of interests in a limited liability company. These securities were offered and sold to residents of California and elsewhere.

7. These securities were offered and sold by means of general solicitation. Desert Wind Entertainment “cold called” people to offer and sell these securities.

8. These securities were offered and sold in this state in issuer transactions. The Department of Corporations has not issued a permit or other form of qualification authorizing any person to offer or sell these securities in this state.

Based upon the foregoing findings, the California Corporations Commissioner is of the opinion that the interests in a limited liability company that are being or have been offered or sold by Desert Wind Entertainment, LLC; Joshua Mills; Steven Camp; T.J. Amato; and Patricia Gillum are securities subject to qualification under the California Corporate Securities Law of 1968 and are being or have been offered or sold without being qualified in violation of Corporations Code section 25110. Pursuant to section 25532 of the Corporate Securities Law of 1968, Desert Wind Entertainment, LLC; Joshua Mills; Steven Camp; T.J. Amato; and Patricia Gillum are hereby ordered to desist and refrain from the further offer or sale in the State of California of securities, including but not limited to interests in a limited liability company, unless and until qualification has been made under the law or unless exempt.
