THE STATE BANKING SYSTEM IN 2010

Commercial Banks

New Banks

On January 1, 2010, there were 208 state-chartered commercial banks. During the year, one commercial bank opened for business and nine banks were closed and ordered liquidated. Two national banks converted to state charter, ten banks became extinct through merger and one bank voluntarily surrendered its license in 2009 that was not previously reported, bringing the total number of state-chartered commercial banks to 191 at yearend.
