12	(For violations of sections 17200 and 17403 of the California Financial Code)		
13			
14	The California Corporations Commissioner finds that:		
15			
16	1. California-trade.com and Robert Shipley have engaged in the business of an escrow agent		
17	by advertising escrow services over the internet at www.california-trade.com from in or about 2002		
18	to the present as follows:		
19	a) California-trade.com represents on its website that the process works as follows:		
20	The buyer pays the amount of the purchase price, plus any shipping and escrow fees, to California-		
21	trade.com. The seller ships the goods. Once the buyer receives the goods and is satisfied, California-		
22	trade.com pays the transaction price, less its fee, to the seller.		
23	b) California-trade.com claims on its website that it protects both buyers and sellers		
24	from fraud with these procedures.		
25	c) California-trade.com and Robert Shipley have represented themselves to be		
26	licensed escrow agents by advertising that the company is California Escrow Service, Inc., located at		
27	618 S. Serrano Ave., 2nd Floor, Los Angeles, CA 90005, license number 9631948		
28	d) Although the Department of Corporations issued escrow license number 963-1948

to California Escrow Service, Inc., at the above-listed Los Angeles address, neither Robert Shipley
nor California-trade.com are affiliated with California Escrow Service, Inc. California Escrow
Service, Inc., does not have a website and does not process escrows involving personal property over
the internet.

2. Neither California-trade.com nor Robert Shipley has been issued a license from the
Commissioner authorizing them to conduct business as an escrow agent, as required by California
Financial Code section 17200.

4. Neither California-trade.com nor Robert Shipley is exempt from the licensing requirements of Section 17200.

5. Neither California-trade.com nor Robert Shipley has been issued a license from the Commissioner authorizing them to use words indicating that they are in the escrow business, as required by California Financial Code section 17403.

17 Based upon the foregoing findings, the California Corporations Commissioner is of the opinion that 18 California-trade.com and Robert Shipley and their officers directors, partners, agents, employees 19 and/or servants are in violation of California Financial Code sections 17200 and 17403(a). Pursuant 20 to California Financial Code section 17416, California-trade.com and Robert Shipley are hereby 21 ordered to desist and refrain from engaging in the business of receiving escrows for deposit or 22 delivery without first obtaining a license from the Commissioner. Pursuant to California Financial 23 Code section 17403(b), California-trade.com and Robert Shipley are further ordered to immediately 24 desist and refrain from issuing, circulating, or publishing any advertisement by means of any 25 communication, including any website, or making use of or circulating any letterheads, billheads, 26 blank notes, blank receipts, blank escrow instructions, certificates, circulars, or any written or printed 27 paper containing any fictitious or corporate name or other words indicating that they are in the 28 escrow business. This Order is necessary, in the public interest, for the protection of investors and

1	consistent with the purposes, policies and provisions of the California Escrow Law. This order shall		
2	remain in full force and effect until further order of the California Corporations Commissioner.
