- 2. On or around January 25, 2019 the Department served BDI with the Accusation via certified mail at its principal place of business on file with the Department located at 601 East Glenoaks Boulevard, Suite 101, Glendale, California 91207.
- 3. BDI has not requested an administrative hearing to challenge the allegations contained in the Accusation, and the statutory time period to request an administrative hearing has expired.

NOW, GOOD CAUSE APPEARING THEREFORE, it is hereby ordered, pursuant to Financial Code section 17608, that the joint control agent's license of Builders Disbursements, Inc. be suspended for the *greater* period of: (1) six months, to commence on February 22, 2019, and continue through close of business on August 22, 2019; or (2) until Builders Disbursements, Inc. has submitted the following: (i) its 2017 annual audit report that was due on April 16, 2018; (ii) financial statements, including the general account bank statement and reconciliation, for the periods ending on August 31, 2017 and January 31, 2018; and (iii) financial statements, including the general account bank statement and reconciliation, for the last four quarters immediately preceding the date of submission, including but not limited to March, June, September, and December 2018.

During the period of suspension, Builders Disbursements, Inc. shall not accept any new escrow or joint control business, but may continue to process prior and open escrows in accordance with Financial Code section 17609.

It is further ordered that Builders Disbursements, Inc. shall provide the Commissioner, attention to Sophia C. Kim, Senior Counsel, by the close of business on March 7, 2019, a list of all open escrows with escrow numbers and escrow party names along with a copy of the signed escrow instructions generated by Builders Disbursements, Inc. and/or signed deposit receipt(s), if any, or a copy of Builders Disbursements, Inc.'s generated escrow instructions and the transmittal letters to the parties for the last opened escrow. "Open escrow" means an escrow wherein the parties to such escrow have already entered into a binding agreement and monies and/or escrow
