1. Section 260.211.4 is adopted to read:

§260.211.4. Exemption for Finders: Form.

- (a) An exemption from the provisions of Section 25210 may be obtained from the Commissioner of Business Oversight by a natural person, e.g., individual, who meets the definition of a finder in subdivision (a) of Section 25206.1 of the Code.
- (b) Initial Filing: An individual seeking exemption as a finder pursuant to Section 25206.1 of the Code must file with the Commissioner the Statement of Information form set forth in subsection (g) of this section. The Commissioner may request additional information, documentation or detail pertaining to the form to be filed with the Department.
- (c) Filing Fee: The fee for filing an initial Statement of Information is \$300.00 as prescribed in Section 25206.1, subdivision (c)(2), of the Code. The individual must remit the fee payable to the Department of Business Oversight with the Statement of Information. The fee is not refundable.
- (d) Completion of Filing: A Statement of Information is not considered filed until the required fee and a completed form are received by the Commissioner.
- (e) Amendment to the Statement of Information: A finder must notify the

 Commissioner of any change to the information in the initial Statement of Information

 filed with the Commissioner by filing an amended Statement of Information in

 accordance with the form instructions within 10 business days of the change.

- (f) Exemption Ineligibility: The following individuals are ineligible for the exemption as a finder under Section 25206.1 of the Code and if acting as a broker-dealer as defined in Section 25004 or an agent as defined in Section 25003 of the Code, must register as a broker-dealer pursuant to Section 260.211 or an agent pursuant to Section 260.210 of these rules, unless the individual is otherwise exempt from Section 25210 of the Code:
- (1) An individual who fails to meet the definition of a finder in Section 25206.1, subdivision (a), of the Code,
- (2) An individual who has committed any of the acts or satisfied any of the circumstances described in Section 25212 of the Code or Rule 506(d) of Regulation D under the Securities Act of 1933 (17 C.F.R. 230.506(d)), or
- (3) An individual who is registered as a broker-dealer pursuant to Section 260.211 or an agent pursuant to Section 260.210 of these rules.
 - (g) The Statement of Information shall be filed on the following form:

(g)Any known or foreseeable disclosures of the information pursuant to subdivision (e) or (f) of Civil Code Section 1798.24 may include transfers to federal, state or local law enforcement or regulatory agencies, or to a self-regulatory organization, as authorized by law.

(h)Subject to certain exceptions or exemptions, the Information Practices Act grants an individual a right of access to personal information concerning the requesting individual that is maintained by the Department of Business Oversight.

- § 260.211.5. Annual Renewal of Exemption for Finders: Form.
- (a) Filing: A finder must annually renew the exemption by filing the Statement of Information form in subsection (g) of Section 260.211.4 of these rules with the Commissioner of Business Oversight in accordance with the form instructions on or

before the filing date specified in Section 25206.1, subdivision (d)(1), of the Code. The Commissioner may request additional information, documentation or detail pertaining to the form to be filed with the Department.

- (b) Filing Fee: The fee for filing the renewal Statement of Information is \$275.00 as prescribed in Section 25206.1, subdivision (d)(2), of the Code. The finder must remit the fee payable to the Department of Business Oversight with the Statement of Information. The fee is not refundable.
- (c) Completion of Filing: A Statement of Information is not considered filed until the required fee and a completed form are received by the Commissioner.
- (d) Amendment to the Statement of Information: A finder must notify the

 Commissioner of any change to the information in the renewal Statement of Information

 filed with the Commissioner by filing an amended Statement of Information in

 accordance with the form instructions within 10 business days of the change.
- (e) Registration as a Broker-Dealer or Agent Required: A finder who commits any of the following acts does not meet the requirements for the exemption as a finder and, if acting as a broker-dealer as defined in Section 25004 or an agent as defined in Section 25003 of the Code, must register as a broker-dealer pursuant to Section 260.211 or an agent pursuant to Section 260.210 of these rules, unless the individual is otherwise exempt from Section 25210 of the Code:
- (1) Failure to renew the exemption or pay the renewal filing fee to the

 Commissioner before the filing due date specified in Section 25206.1, subdivision (d), of the Code,
- (2) Failure to comply with the conditions for a finder in Section 25206.1, subdivision (a), of the Code,

- (3) Performance of any of the acts or satisfaction of any of the circumstances in Section 25212 of the Code or Rule 506(d) of Regulation D under the Securities Act of 1933 (17 C.F.R. 230.506(d)) pursuant to Section 25206.1, subdivision (d)(1)(A)(ii), of the Code,
- (4) Failure to obtain a signed written agreement or the written consent of each person introduced or referred by the finder, or to provide the disclosures and information in accordance with Section 25206.1, subdivision (e), of the Code,
- (5) Failure to disclose whether transaction-based compensation was received as specified in Section 25206.1, subdivision (d)(1)(B), of the Code, and
- (6) Failure to maintain the records required under Section 25206.1, subdivision (f).

§260.211.6. Notification of Withdrawal: Finder.

A finder must notify the Commissioner of Business Oversight within 15 calendar days of the finder withdrawing from engaging in business under the exemption by filing the Statement of Information form in subsection (g) of Section 260.211.4 of these rules with the Commissioner in accordance with the form instructions.

4. Section 260.211.7 is adopted to read:

- §260.211.7. Maintenance of Records.
- (a) A finder must make and keep the written agreement and any other records for the time period specified in Section 25206.1, subdivision (f), of the Code.
- (b) The records must be maintained at the location designated by the finder in the Statement of Information.
- (c) The records are subject at any time to examination by the Commissioner of

 Business Oversight as the Commissioner deems necessary or appropriate in the public interest or for the protection of investors.
- (d) The prohibition against fraudulent and misleading acts in Section 25401 of the Code applies to a finder.
