26	written argument or supporting documentation. Neither party did so.
27	On or about October 12, 2018, the Commissioner served Lamb Energy an Order granting the

2	1. File with the Commissioner a current balance sheet as evidence of compliance
3	with Lamb Energy Finance, LLC's net worth as of March 31, 2018.
4	2. File with the Commissioner the 2014 Annual Report of Lamb Energy Finance,
5	LLC.
6	3. File with the Commissioner a current surety bond for Lamb Energy Finance,
7	LLC.
8	4. Pay a penalty of \$3,500.00 to the Commissioner for failing to file the 2014
9	Annual Report in violation of Financial Code section 22159.
10	The Commissioner finds that Lamb Energy has complied with all conditions for
11	reinstatement of its license and is otherwise fit to engage in the business of finance lending.
12	THEREFORE, IT IS ORDERED that the Petition for Reinstatement is granted and Lamb
13	Energy, LLC's CFL license, license number 603J284, is hereby reinstated effective as of the date of
14	this Order.
