- 3. On December 11, 2018, the Commissioner issued to AmeriPro a Notice of Intention to Issue Order Revoking Residential Mortgage Lender License, Accusation to Revoke Residential Mortgage Lender License, and accompanying pleadings (Accusation). The Accusation is hereby incorporated by this reference.
- 4. On or around December 18, 2018 and February 26, 2019, the Department sent the Accusation via certified mail to AmeriPro's principal place of business and last known addresses. To date, the Department has not received a request for a hearing from AmeriPro and the time to request a hearing has expired.

Therefore, based on the foregoing and good cause appearing, , it is hereby ORDERED that pursuant to Financial Code section 50327, the residential mortgage lender license of AmeriPro Funding, Inc., d.b.a. AmeriPro Home Loans, a.k.a. Hello Mortgage, Inc. be revoked. This order is effectively immediately, however pursuant to Financial Code section 50311, AmeriPro Funding, Inc., d.b.a. AmeriPro Home Loans, a.k.a. Hello Mortgage, Inc. has a transition period of 60 days within which to complete any loans for which it had prior commitments.
