Plaintiff, the People of the State of California (the People) by and through the Commissioner of Business Oversight (Commissioner), filed a Complaint on March 15, 2019 and a First Amended Complaint on August 20, 2019 pursuant to section 25530 of the Corporate Securities Law of 1968 (Corporations Code section 25000 et seq.), to enjoin Defendants Martians Incorporated and Danny Jay Scheuer, also known as Daniel Scheuer, Dan Scheuer, Dan J. Scheuer, Daniel J. Scheuer, and Dan Shire, (Defendants) from violating the CSL and violating the administrative desist and refrain orders issued by the Commissioner, and for other relief including restitution to investors and civil penalties to the Commissioner. Defendants are in default.

1 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

2 1. Pursuant to California Corporations Code section 25530, subdivision (a),  
3 Defendants Martians Incorporated and Danny Jay Scheuer, also known as Daniel Scheuer, Dan  
4 Scheuer, Dan J. Scheuer, Daniel J. Scheuer, and Dan Shire, are permanently enjoined from:

5 a. Violating California Corporations Code section 25110 by offering to sell,  
6 selling, arranging for the sale of, issuing, engaging in the business of selling, or negotiating for the  
7 sale of any security of any kind unless such security or transaction is qualified;

8 b. Violating California Corporations Code section 25401 by offering to sell or  
9 selling any security of any kind by means of any written or oral communication which includes  
10 any untrue statement of material fact or omits to state any material fact necessary in order to make  
11 the statements made, in the light of the circumstances under which they are made, not misleading;  
12 and

13 c. Violating the Desist and Refrain Order issued by the Commissioner to  
14 Defendants Martians Incorporated and Danny Jay Scheuer on July 10, 2012.

15 2. Pursuant to California Corporations Code section 25530, subdivision (a),  
16 Defendants Danny Jay Scheuer, also known as Daniel Scheuer, Dan Scheuer, Dan J. Scheuer,  
17 Daniel J. Scheuer, and Dan Shire, is permanently enjoined from violating the Desist and Refrain  
18 orders issued by the Commissioner to Defendant Danny Jay Scheuer on September 16, 1998 and  
19 October 20, 2000.

20 3. Pursuant to California Corporations Code section 25530, subdivision (b),  
21 Defendants Martians Incorporated and Danny Jay Scheuer, also known as Daniel Scheuer, Dan  
22 Scheuer, Dan J. Scheuer, Daniel J. Scheuer, and Dan Shire, jointly and severally, are ordered to  
23 pay restitution to each of the sixty-three (63) investors set forth in Exhibit 1 hereto, in the total  
24 amount of \$916,010.00 *to be paid to the plaintiff herein, specifically the office of the*  
25 *Commissioner of Business Oversight, and distributed by the Commission to each reflective of their*  
26 *losses as set forth in Ex. 1.*

27 4. Pursuant to California Corporations Code section 25535, Defendants Martians  
28 Incorporated and Danny Jay Scheuer, also known as Daniel Scheuer, Dan Scheuer, Dan J.

1 Scheuer, Daniel J. Scheuer, and Dan Shire, jointly and severally, are ordered to pay civil penalties  
2 to the Commissioner, in the amount of \$800,000.00.

3 5. ~~This Court will retain jurisdiction of this action in order to implement and carry out~~  
4 ~~the terms of all orders and decrees that may be entered herein or to entertain any suitable~~  
5 ~~application or motion by Plaintiff for additional relief within the jurisdiction of this Court.~~
